Member Staff Meeting

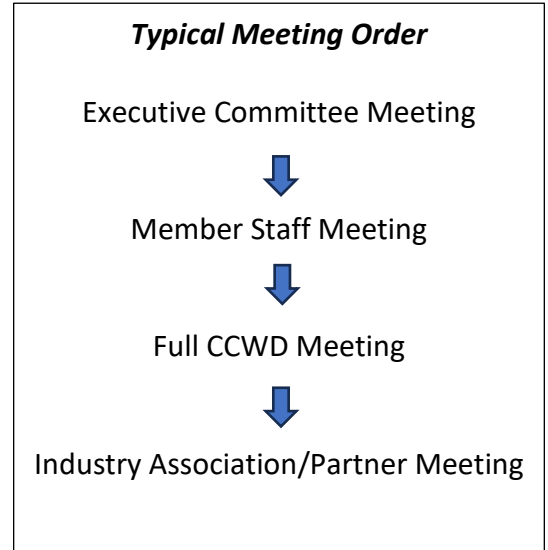
- Cadence: Quarterly
